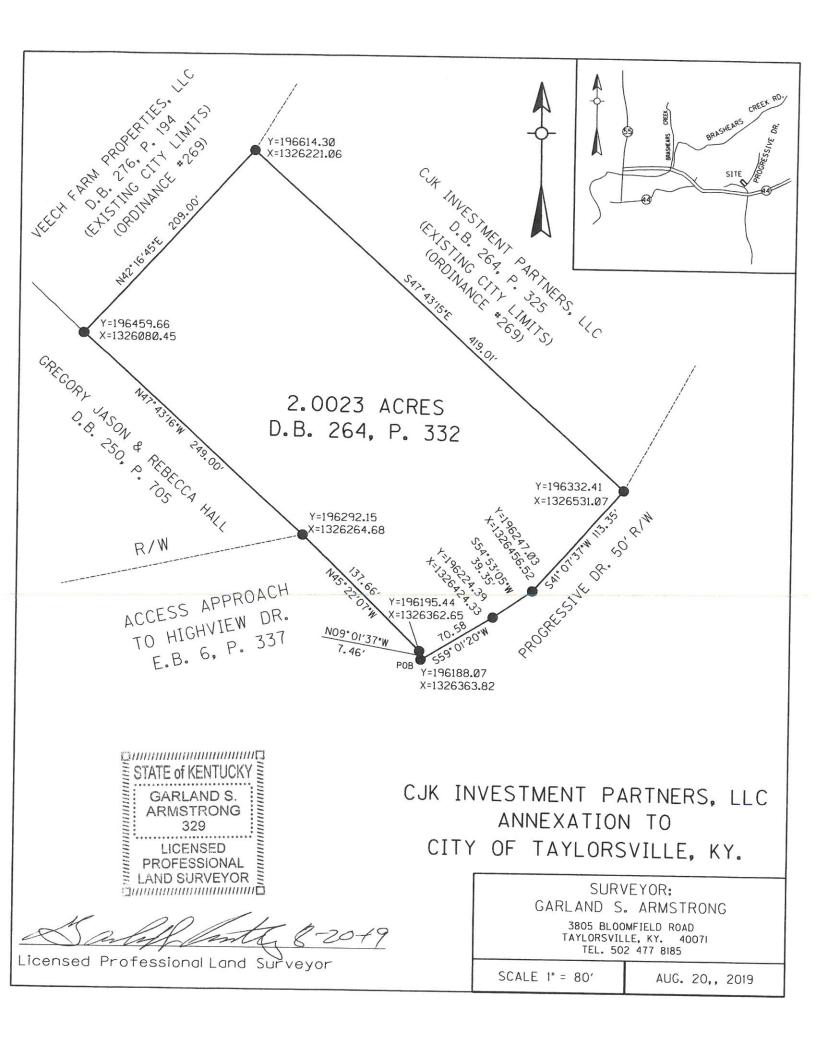
WHEREAS, it is desirable to annex said unincorporated territory.
