## **ORDINANCE NO. 404**

## AN ORDINANCE CLOSING A PORTION OF PARK ALLEY, A PUBLIC WAY, BETWEEN MAIN CROSS AND REV. CHARLES BURTON WAY, (formerly Jefferson Street)

WHEREAS, KRS 82.405 sets forth the procedure for closing a public way within a City, and

WHEREAS, the Spencer County Board of Education (the Board), 207 West Main Street, Taylorsville, Ky., has requested the City of Taylorsville's City Commissioners, the legislative body of the City of Taylorsville, a Home Rule commission form of city government, to close a portion of Park Alley, between Main Cross and Rev. Charles Burton Way (formerly Jefferson Street), abutting property owned by the Board, as described on what is identified as Minor Subdivision Pat date September 22, 2019, a copy of which is attached hereto and incorporate by reference herein, as recorded in Plat Cabinet 6 Slide 162 in the Spencer County Clerk's Office, so the Board may utilize that portion of Park Alley, which abuts property owned by the Board, in conjunction with the construction of a new education center by the Board, to be used for a public purpose, and

WHEREAS, the City Commissioners deems it in the public's best interest to close that portion of Park Alley between Main Cross and now Rev. Charles Burton Way, which abuts the property owned by the Board, and

WHEREAS, the City of Taylorsville, City Commission, being the legislative body of the City of Taylorsville, pursuant to KRS 82.405(2), makes the following:

## Findings of Facts

- (a) The Spencer County Board of Education is the only property owner in or abutting the portion of Park Alley which is to be closed between Main Cross and Rev. Charles Burton Way, (formerly Jefferson Street);
- (b) Written notice of the proposed closing has been given to the Board;

(c) The Board, being the only property own in or abutting the portion of Park Alley to be closed, has given it's written notarized consent to the closing of said public way, a copy of the Notarized Consent is attached hereto and incorporated reference herein.

THEREFORE, be it Ordained by the City of Taylorville, and the City Commissioners,

The said described portion of Park Alley, a public way, located between Main Cross and Rev. Charles Burton Way in Taylorsville, Kentucky and which is abutted by the property owned by the Spencer County Board of Education, IS HEREBY DECLARED CLOSED.

Enacted this the \_\_\_\_\_ day of January 2020, at a regular meeting of the City of Taylorsville and the City Commission, and which will become effective following the date of the second reading and the publication of the Summary of this Ordinance, in accordance with to KRS 83A.060(4)and (9)
