Item #2- Public Hearing 2021-2022 Budget

The budget totals were available for review and comment along with Municipal Road Aid Projects budgeted for the year.

No public comments were received.

Item #3 – Budget FY 22 - Ordinance #415 (1st Reading)

Clerk Biven highlighted changes made from the Public Notice for the first reading of the Ordinance. He led the Commission through a review of the budget detailing dollar amounts for the General Fund, Water/Sewer, and the Road Aid Fund.
