Item #1- Open Meeting

Mayor Douglas called the meeting to order at 1:00 PM.

Item 2# – E-check Service to Customers

Stacey Crenshaw, Customer Service Representative addressed the Commission regarding providing E-check services to City of Taylorsville customers. E-check services would allow customers to pay monthly statements by calling in checking account information. There is a minimal processing fee of \$1.50.

Motion was made by Commissioner Ingram and Seconded by Commissioner Bowens to provide E-check services for customers that would like to pay monthly invoices over the phone. Motion carried with a vote of 5-0.

Item 3# - Ordinance #422, Compensation of Elected Officials (1st Reading)

Steve Biven, City Clerk, addressed the Commission regarding Ordinance #422, Compensation of Elected Officials. The COLA was discussed in relation to the large rate of inflation that we are currently experiencing.

Motion was made by Mayor Douglas to set the salary for the new Commission beginning in 2023 at \$13,415.64 for the Mayor and \$10,163.00 for the Commissioners. The motion failed due to the lack of a second.

Motion was made by Commissioner Ingram and seconded by Commissioner Spears to set the salary for the new Commission beginning in 2023 at \$12,780.00 for the Mayor and \$9,680.00 for the Commissioners. The motion carried with a vote of 4-1. Commissioner Nation, Commissioner Ingram, Commissioner Spears and Commissioner Bowens voted in favor. Mayor Douglas opposed.


