WHEREAS, Personnel Policies (Plans) relate to the internal operations and functions of the City and, to save the time and the cost of enacting and of publishing Ordinances in regard to the City's Personnel Policies (Plans).

THEREFORE BE IT ORDAINED by the City of Taylorsville as follows:

Section 1:

That any and all prior Ordinances regarding or relating to the City's Personnel Policies (Plans), particularly Ordinance #136, Ordinance#99-190, Ordinance #203 and Ordinance #256 are hereby repealed.

Section 2:

That the City herein adopts the provisions of KRS 83A.060(13) to use Municipal Orders in lieu of Ordinances in regard to the City's Personnel Policies (Plans).

Section 3:

That if any sentence, clause, section or part of this Ordinance or the application thereof is found to be contrary to law or for any reason invalid, such shall not affect or repeal any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance.

Section 4.

This Ordinance shall become effective from and after its passage and publication.
