WHEREAS, the City of Taylorsville deems it necessary and appropriate to have a Citation Officer/Enforcement Officer to enforce City Ordinances, particularly the Nuisance Abatement Ordinances and the Unsafe Structure Ordinances.

THEREFORE, BE IT ORDAINED by the City of Taylorsville as follows:

The City herein creates the position of Citation Officer pursuant to KRS 83A.087, who's duties and responsibilities are those that are set forth in KRS 83A.087 and other appropriate statutes and further creates the position of Enforcement Officer, which duties and responsibilities will be combined with those of the Citation Officer.

The duties and responsibilities of the Citation Officer/Enforcement Officer will be as directed by the City of Taylorsville, primarily to enforce the City's Nuisance Abatement Ordinances and Unsafe Structure Ordinance and any such other appropriate Ordinance as deemed by the city.

The Citation Officer/Enforcement Officer's immediate supervisor shall be the Police Chief for the City of Taylorsville, then subsequently the City Clerk, the Commissioner over the Police Department and then the City Commission.

The compensation for said position shall be set by the City.

As an employee of the City, the Citation Officer/Enforcement Officer shall comply with all the provisions and regulations of the City, particularly the City's Personnel Policies.

The said official may be referred to as the Citation Officer and/or as the Enforcement Officer.

This Ordinance shall take effect from and after its passage and publication.


