ORDINANCE NO. 383

**AN ORDINANCE PROVIDING FOR COMPENSATION OF
ELECTED OFFICIALS FOR THE CITY OF
TAYLORSVILLE, KENTUCKY, PURSUANT TO KRS
83A.070(1).**

WHEREAS, KRS 83A.070(1) provides that the legislative body of each city shall by ordinance, fix the compensation for each elected official not later than the first Monday in May in the year in which the officer is elected and whereas 2018 is the election year for the City Commissioners and the Mayor for the City of Taylorsville.

THEREFORE, BE IT ORDAINED by the City of Taylorsville that the annual compensation for each Commissioner for the City of Taylorsville shall be \$8,500.00 per year, during the Commissioner's two year term of office and the annual compensation for the Mayor of the City of Taylorsville shall be \$11,220.00 per year, during the Mayor's four year term of office.

Aforesaid compensation shall be prorated and paid monthly beginning January 1, 2019.

The aforesaid compensation is subject to the annual cost of living adjustments that may be made pursuant to KRS 83A.075.

Any Ordinance inconsistent herewith is hereby repealed.

This Ordinance shall take effect from and after its passage and publication.

The aforesaid compensation is subject to the annual cost of living adjustments that may be made pursuant to KRS 83A.075.

Any Ordinance inconsistent herewith is hereby repealed.
