ORDINANCE NO. 391

AN ORDINANCE OF THE CITY OF TAYLORSVILLE, SPENCER COUNTY KENTUCKY, CREATING FRANCHISE FOR BID PROPOSALS FROM PARTIES INTERESTED IN OBTAINING FRANCHISES PURSUANT TO SECTIONS 163 AND 164 OF THE KENTUCKY CONSTITUTION AND OTHER APPROPRIATELAWS OF KENTUCKY, TO ERECT, INSTALL, LAY AND MAINTAIN OF FACILITIES AND APPURENANT FACILITIES AND EQUIPMENT IN AND ALONG AND ACROSS THE PUBLIC WAYS, ROADS, STREETS, ALLEYS AND OTHER PUBLIC PLACES IN THE CITY OF TAYLORSVILLE, KENTUCKY: FOR FURNISHING AND SELLING COMMUNICATION SERVICES BY MEANS OF SAID FACILITIES; AND PROVIDING FOR THE SALE OF SAID FRANCHISE.

WHEREAS, the City of Taylorsville ("City") wishes to ensure that communications service continues to be furnished to its citizens in a reliable and efficient manner;

WHEREAS, the City is aware that the provision of such service requires the continued use of public streets, ways, alleys and other public places;

WHEREAS, in accordance with Section 163 and 164 of the Kentucky Constitution and other appropriate laws of the Commonwealth of Kentucky, the City wishes to provide for the sale of communications franchise for the benefit of its citizenry;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF TAYLORSVILLE as follows:

Section 1. A non-exclusive franchise ("Franchise") to use the City's public rights-of-way, as within the City of Taylorsville boundaries is herby created to provide communication services within the City of Taylorsville.

Section 2. The Franchise created by this Ordinance shall be bid in accordance with the applicable requirements of the Constitution of the Commonwealth of Kentucky and Chapter 424 of the Kentucky Revised Statutes, as well as any applicable City ordinances.

Section 3. The Franchise created by this Ordinance shall be awarded to the highest and best bidder, as shall be determined by the City in its sole discretion. In awarding the Franchise, the City shall consider the technical, managerial, and financial qualifications of the bidder to perform its obligations under the Franchise.

Section 4. The winning bidder and the City shall negotiate, execute and be bound by a Franchise Agreement with terms such that are fair and reasonable to the City, to the purchaser of the Franchise and to the patrons thereof. Such Franchise Agreement shall take effect no earlier than 60 days after its execution, to allow the City and the winning bidder to develop appropriate procedures for identifying and reviewing the consuming entities within the City's corporate limits.

<u>Section 5.</u> All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.

Section 6. Should any section, clause, line, paragraph, or part of this Ordinance or the attached Franchise Agreement be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance or the attached Franchise Agreement, as applicable.

Section 7. Time is of the essence in carrying out the terms and the provisions of this Ordinance and the Franchise created herein.

Section 8. This Ordinance shall become effective from and after its passage and publication.
