

**AN ORDINANCE REPEALING ORDINANCE No. 365 AND AMENDING ORDINANCE
348 SECTION 5.01 AND ESTABLISHING HOURS FOR THE LAWFUL SALE OF
ALCOHOL IN THE CITY OF TAYLORSVILLE**

ORDINANCE No. 442

WHEREAS, pursuant to the police and other powers granted cities by the Constitution of the Commonwealth of Kentucky, by KRS 82.082 commonly known as the "Home Rule" statute, and further by KRS 65.8840, along with all other applicable Statutes and regulations, the city Commission has enacted certain Ordinances regulating the sale and service of alcohol within the city of Taylorsville, Kentucky.

WHEREAS, it has been determined by the City Commission that the sale of alcohol on certain Sundays and on certain specified Holidays is appropriate and in the economic interest of the community,

THEREFORE, BE IT ORDAINED by the Commission for the City of Taylorsville, Kentucky as follows:

SECTION I:

City of Taylorsville Ordinance No. 365, enacted on or about May 18th, 2016 and relating to the hours during which alcohol may be lawfully served and or sold within the City of Taylorsville, IS HEREBY REPEALED IN ITS ENTIRITY.

SECTION II:

That City Ordinance #348, Section 5.01 HOURS OF SALE, Subparagraph (A), is hereby amended and shall read as follows:

A. Premises for which there has been granted a license for the retail sales of alcoholic beverages shall be permitted to sell or offer for sale alcoholic beverages only between the hours of 6:00 a.m. and 12:00 a.m. each day, except Sunday. It shall be ~~unlawful~~, [lawful] to sell or offer any alcoholic beverage ~~during the twenty four (24) hours of each Sunday~~ on Sundays between the hours of 1:00 p.m. and 12:00 am.]

[Notwithstanding the prohibitions and time frames set forth above, licensees as described above may additionally sell or offer for sale alcoholic beverages on December 31st, through the next following January 1st as follows:

i. Any year in which December 31st falls on a Saturday, licensees may sell or offer for sale alcoholic beverages from 6:00 a.m. Saturday, December 31st, through 1:00 a.m. on the next following Sunday.

ii. Any year in which December 31st falls on a Sunday, licensees may sell or offer for sale alcoholic beverages from 1:00 p.m. Sunday, December 31st, through 1:00 a.m. on the next following Monday.]

SECTION III: This Ordinance shall be in full force and effect upon its adoption, recordation, and publication as required by Law.


