Item #1- Mayor Spencer called the meeting to order at 5:00 p.m. Clerk Biven called the roll.

Item #2 - Garbage Contract

Representatives from Rumpke and Republic Services discussed their proposals for garbage collection services.

Motion was made by Commissioner Nation and seconded by Commissioner Hilbert to accept the Garbage Collection Proposal from Rumpke. Commissioner Nation and Commissioner Hilbert voted in favor. Commissioner Spears and Commissioner Bowens opposed. Mayor Spencer abstained. Motion failed 2-2

City Attorney Myles explained the legal ramifications of a tie vote. Representatives from Rumpke and Republic Services further discussed their proposals.

Motion was made by Commissioner Hilbert and seconded by Commissioner Nation to accept the Garbage Collection Proposal from Rumpke provided that the benefits of the additional cost are explained to the residents. Commissioner Nation, Commissioner Hilbert and Commissioner Spears voted in favor. Commissioner Bowens opposed. Mayor Spencer abstained. Motion carried 3-1.
