Ordinance No. 443

WHEREAS, it has been determined by the Taylorsville City Commission that acceptance of the following named pass-ways is in the best interests of the City.

NOW THEREFORE be it ordained by the City Commission of the City of Taylorsville as follows:


SECTION I: That the pass-ways known as New Orleans Court, 437 feet in total current length and Nashville Court, 508 feet in total length are accepted as City streets for all purposes.

SECTION II: This Ordinance shall be in full force and effect upon its adoption, recordation, and publication as required by Law.

AN ORDINANCE ACCEPTING AND DEDICATING CERTAIN SPECIFIED
PASSWAYS WITHIN THE CITY OF TAYLORSVILLE AS PUBLIC WAYS
AND CITY STREETS FOR ALL PURPOSES

City of Taylorsville, Kentucky

Ordinance No. 443

WHEREAS, construction has been completed on Nashville Court and a specified portion of New Orleans Court, in the Old South Plantation Subdivision, and it further having been determined that said pass-ways meet the criteria established for public streets within the City of Taylorsville,

WHEREAS, it has been determined by the Taylorsville City Commission that acceptance of the aforementioned pass-ways is in the best interests of the City of Taylorsville and the citizens thereof.

NOW THEREFORE be it ordained by the City Commission of the City of Taylorsville as follows:

SECTION I: That the pass-way known as New Orleans Court, located within the Old South Plantation Subdivision, within the City of Taylorsville, Kentucky and being approximately 437 feet in total current length beginning at its intersection with Turnpike Avenue, and that the pass-way known as Nashville Court, located within the Old South Plantation Subdivision, within the City of Taylorsville, Kentucky and being approximately 508 feet in total length beginning at its intersection with the above described New Orleans Court, are hereby accepted, as a public ways and City streets within the City of Taylorsville, Kentucky, for all purposes.

Each of the above described streets being more particularly described on the plat attached hereto and made a part hereof for all purposes.

SECTION II: This Ordinance shall be in full force and effect upon its adoption, recordation, and publication as required by Law.

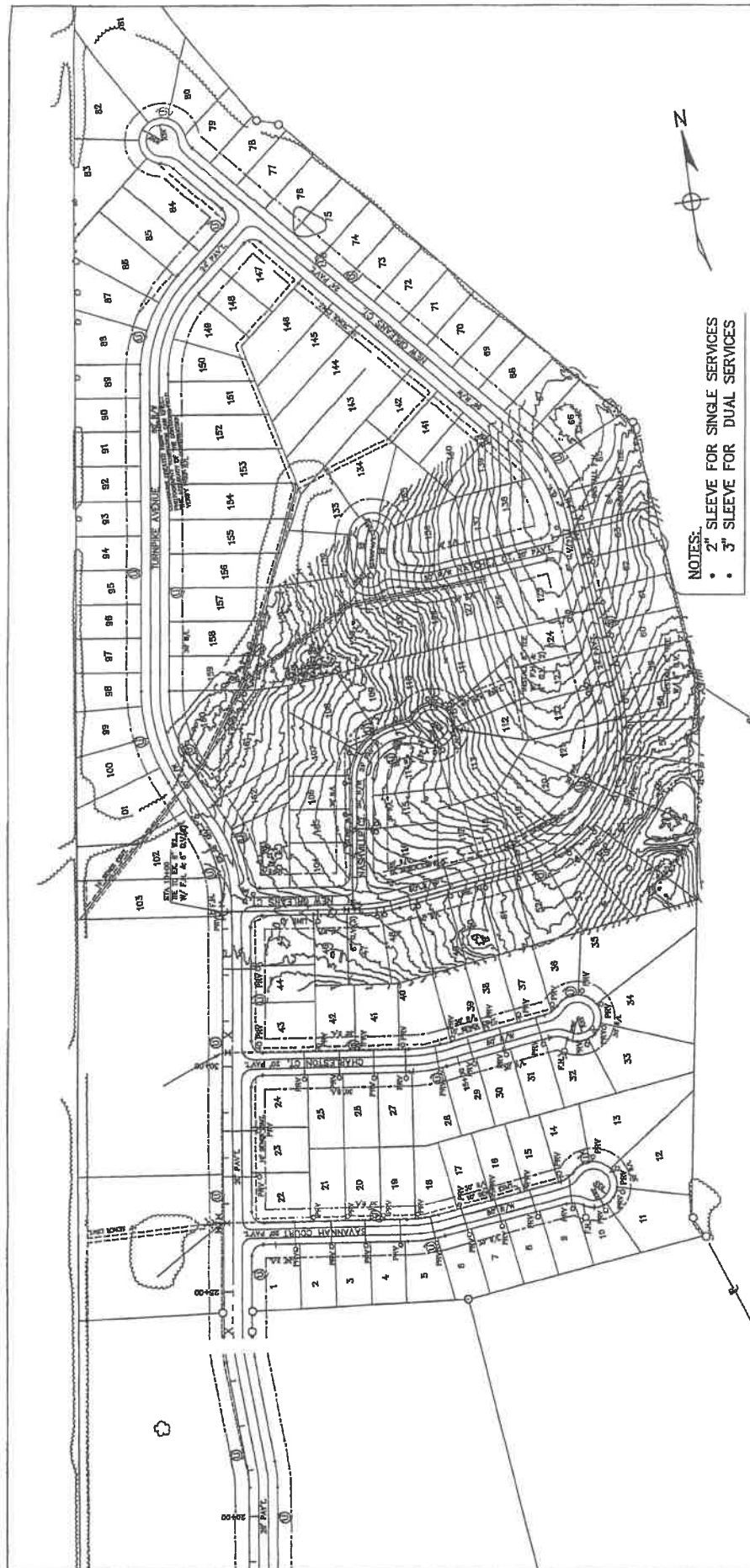
