Item #1- Mayor Spencer called the meeting to order at 6:00 p.m. Clerk Biven called the roll.

# Item #2 - Ordinance T-2024 Property Tax Rates (Second Reading)

Clerk Biven gave the second reading of Ordinance T-2024, an ordinance levying an ad valorem tax on all real and personal property within the corporate limits of the City of Taylorsville

Motion was made by Mayor Spencer and seconded by Commission Hilbert to approve Ordinance T-2024. Motion carried with a vote of 5-0.

#### Item #4 - Chamber Parking Lot Paving

# Item #5 – Surplus Property

The City Attorney has prepared resolutions to surplus a police vehicle and various items of equipment in the public works department. Mr. Compton needs to refine his list of items.

Motion was made by Commissioner Bowens and seconded by Commission Hilbert to approve Resolution 2024-005 regarding a surplus police vehicle. Motion carried with a vote of 5-0.

### Item #6 – City Streets

### Item #7 - City Hall & Annex Renovation

Public Works Director Compton provided a quote on replacing the windows at city hall.

Motion was made by Commissioner Bowens and seconded by Commission Nation to accept the quote from Brian Bentley Construction of \$12,779 to remove and install 60/40 glass at city hall. Motion carried with a vote of 5-0.

#### Item #8 - Nuisances

The city attorney and code enforcement officer have yet to meet with the owners of the property at 114 Main Street regarding the citation issued by the city, along with possible foreclosure, condemnation or demolition of the structure.

# Item #9 - State Surplus Fund Projects

Representative Tipton is asking the City to pass a resolution noting possible projects for funding from excess sales tax revenue. The City Attorney will work on that resolution with items listed in an attachment. The City Commission, Chief Sumner, Public Works Director Compton and Comptroller Burke have presented various items to submit for funding and estimates were provided. Mr. Burke explained his listings. A list of these items was prioritized and will be further discussed at the next meeting.
