

ORDINANCE FORGOING A NONPARTISAN PRIMARY ELECTION FOR  
CITY OFFICIALS OF CITY OF TAYLORSVILLE, KENTUCKY

Ordinance No. 476

WHEREAS, pursuant to KRS 83A.045(2)(b), the City Commission for the City of Taylorsville, Kentucky proposes the following Ordinance relating to the election of City officials.

NOW THEREFORE be it ordained by the City Commission of the City of Taylorsville, Kentucky, as follows:

**SECTION I:**

That any and all City of Taylorsville, Kentucky Ordinances, relating to the non-partisan election of City Officials and which address the specific issues set-forth below, are **HEREBY REPEALED ONLY IN SO FAR** as such prior Ordinance is in conflict with the following; it being the intent of the City Commission that this Ordinance shall control.

**SECTION II:**

A) Pursuant to KRS 83A.045 (2)(b) the City of Taylorsville, Kentucky shall forgo conducting a nonpartisan primary for the nomination of candidates to any and all City elected offices, regardless of the number of candidates running for any office.

B) All candidates shall file their nomination papers with the Spencer County Clerk not earlier than the first Wednesday after the first Monday in November of the year preceding the year in which the office will appear on the ballot.

C) All candidates shall file their nomination papers with the Spencer County Clerk not later than the first Tuesday after the first Monday in June before the day fixed by KRS Chapter 118 for holding a regular election for office.

D) The number of candidates equal to the number of City offices to be filled who receive the highest number of votes cast in the regular election for each City office shall be elected.

**SECTION III:** This Ordinance shall be in full force and effect upon its adoption, recordation, and publication as required by Law.
